Superscript note explanations:

1 Legal Research & Writing (OCT) begins 10/5/2020-ends mid-December; Introduction to Law (OCT) begins 10/6/2020 - ends mid-December.

2 Law Study & Exams - session starts 10/1/2020 and ends 12/10/2020, then restarts 1/7/2021 and ends 2/4/2021.

3 Legal Aid Clinic - option to take for 2 or 3 units

4 Clinical Education is available to 3rd- and 4th-year students only.

5 Disability Law Clinic is limited to 6 students. (Option to take for 1 or 2 or 3 units.)
